Tuition Policies

Monthly tuition is due on 1st of the month. LRDA doesn't send tuition bills or reminders; tuition is delinquent after the 7th of month. **A \$15.00 late fee is automatically assessed after the 7th** _____ (Initial)

Some months have 5 dance classes, some have 4 and some have 3 (due to holidays). Tuition is calculated based on the total weeks during the **entire school year** therefore you are **charged the same amount each month**. Students who Register and Enroll after the first week of the month are eligible for pro-rated tuition based on the single class rate. _____ (Initial)

Tuition is non-refundable. All classes must be made-up or forfeited. Some classes are only offered once a week and no make class is available. In this case missed class is considered forfeited. Tuition credits will be given only in certain cases of severe and prolonged injury substantiated by medical documentation. _____ (Initial)

LRDA **must be given two weeks written notice** if a class is being dropped. Any student who has not dropped a class in writing will be considered an active student and billed for the month. Accounts remain active until the student has been officially dropped from the program. Add/Drop forms are available at the front desk for this purpose. _____ (Initial)

Indemnification
